### I. The objectives envisaged by the parties of the agreement: • According to this

agreement, which does not carry the status of obligation and adopts the capacity of volunteerism and the spirit of initiative, the Strait of Gibraltar Association will mobilize to participate, exchange expertise and experiences, and assist in achieving the goals set for the MarocAtlas Gibraltar 4x4 Club in Gibraltar, as well as mobilizing donors in Gibraltar as much as possible, and in return The MarocAtlas Gibraltar 4x4 Club will encourage and participate in all the activities of the Gibraltar Association, in addition to receiving young men and women who wish to benefit from the Duke of Edinburgh's International Award to obtain expertise in the areas of working beside the association and provide certificates documenting the involvement of these young men and women. The nomination of young men and women is from 14 to 24 years old, to register for this award, which will help to download sustainable development whose essence is human.

- This agreement constitutes an open framework for communication and cooperation between the Strait of Gibraltar Association and the Maroc Atlas Gibraltar 4x4 Club in various fields: cultural, educational, developmental and social. Commitment to joint work, exchange of expertise, experiences, investments, and cooperation in everything that contributes to development service, rehabilitation of society, solidarity and development networking for the territorial integrity of the Moroccan Kingdom, and harnessing the services, expertise and information available to the parties of the convention.
- This agreement aims to define the elements of voluntary work between the British Overseas Territory of Gibraltar and the Kingdom of Morocco, which is represented in this agreement that considers people as a cornerstone for development, building bridges of cultural and social cooperation, and achieving sustainable development goals in the hope of achieving more success for all youth and young women.

### III. Objectives of the two parties:

### 1- The Strait of Gibraltar Association aims to achieve the following:

- Work on implementing the Duke of Edinburgh's International Award to support youth and refine their capabilities.
- Work on the 2030 Agenda for the Sustainable Development Goals of the United Nations.
  Promoting noble social and humanitarian work among young people.
- Contributing to the development of scientific and technological research among universities.
  Organize and participate in artistic events and festivals in various fields.
- Creating channels for communication and sharing investment issues for young people and current problems.
- Creating partnerships with the public and private sectors to activate youth projects.
  Work to enhance the role of sport among young people.
- Encouraging tourism among young people.
- Organizing trips and camps at the national and international level.
- Contribute to the Civilizations Exchange Program.
- Taking care of migrants' issues.
- Inclusion of marginalized groups in society.
- Creating channels of communication for people with special needs because they are an important category of society by enacting special programs and important workshops that enable them to smoothly integrate into society.

## V. Follow-up methods

### VI. Evaluation



- The two parties hold an annual meeting to evaluate the outcome of the program, and to adopt the results reached as a basis for the following year's program.
- A study is being carried out to assess the impact by the office of the two associations.
- The interim evaluation is carried out based on the round of project activities according to the contracted programmes.
- The results of the annual evaluation can be invested in the framework of the inventory of the best and successful experiences

## VII. Duration of the agreement

This agreement is concluded for a period of 12 months, subject to automatic extension, unless the parties agree otherwise, while respecting the above-mentioned terms.

### VIII. Modify the agreement

This Agreement may be amended or expanded in a new version with the consent of both parties, starting from the date of its ratification

#### IX. Communication

- The two parties agree to encourage their joint future activities
- Establishing an archive in which all press files and photographs related to all cultural and social activities between the two parties are kept.

This agreement is subject to the requirements of positive Moroccan law and all parties to the dispute will always seek to obtain an amicable settlement.
